

Privacy Policy

As used in this Privacy Policy, “Company,” “we,” “our,” and “us” refers to Harmony Homes, together with its members, affiliates, subsidiaries, divisions and brands. The privacy of your information is important to us. This privacy policy applies to information collected online from users of this website. In this policy, you can learn what kind of information we collect, when and how we might use that information, how we protect the information, and the choices you have with respect to your personal information.
